The Board of Lincoln County Commissioners met at 9:00 a.m. on January 7, 2020. The following attended: Chairman Ed E. Schifferns, Commissioners Steve Burgess and Doug Stone, County Administrator Jacob Piper, County Attorney Stan Kimble (until noon), and Clerk to the Board Corinne M. Lengel. Will Bublitz with the Limon Leader/Eastern Colorado Plainsman attended until 10:00 a.m.

Chairman Schifferns called the meeting to order and asked Mr. Bublitz to lead the Pledge of Allegiance.

Mr. Burgess had submitted a correction to the last minutes to Mrs. Lengel via email regarding the discussion about eminent domain. Mrs. Lengel said she'd fixed the typo (the word "should" to "shouldn't"). Mr. Stone made a motion to approve the minutes from the meeting held on December 30, 2019, as corrected. Mr. Burgess seconded the motion, which carried unanimously.

The Board reviewed the employee timesheets for the administrator, land use administrator, landfill manager, emergency manager, and public health director.

In discussing an appointment to the ECCOG board, Mr. Piper said he'd received an email from Candace Payne regarding a tied vote. The commissioners would have to break the tie between Gillian Laycock and Ben Ferree. Melody McKinsey, co-owner of Hugo Lumber, agreed to replace Gary Beedy on the board. Since the location of her business is Hugo, Mr. Burgess felt they should appoint a Limon business-owner. He made a motion to appoint Ben Ferree to the ECCOG board to replace Julie Coonts. Mr. Stone seconded the motion, which carried unanimously.

Mr. Burgess reported that between December 31, 2019, and January 7, 2020, the road crew installed road signs and hauled roto-millings to Karval. They also worked on the lights on the Mack truck and adjusted the passenger door. Bruce Walters went to Lamar to pick up parts for the Ranco trailer. Mr. Burgess got a call from the landfill that the scale wasn't working correctly. Brenda Howe contacted the scale company, and they agreed to come and see what the problem was. They will also certify the scales for weight measurement while they are there.

Mr. Stone reported checking roads south of Karval on January 5.

Mr. Schifferns reported talking to Chris Monks about the new blade after the meeting on December 30. He received several calls about the drones on January 2 and checked roads on January 3. He also spoke with Chris about changing out some culverts on County Road 2W, where water keeps running over the road. Yesterday, Chris caught one of the Shortgrass trucks speeding on 2W where they weren't supposed to be. He called Heather Brickey, but she couldn't tell him anything. Chris informed Mr. Schifferns that Xcel was supposed to be sending the county a check for \$3,500 for violations. Mr. Schifferns also reported that they're thinking about buying a truck with a plow in District One. Mr. Burgess said that since three separate

entities share ownership in the one they have, they'd need to discuss how to handle the finances before they traded it in.

Mr. Kimble said the information about Shortgrass was interesting since they were supposed to meet today to decide how to bring the road back to its original state. They agreed it would take three-to-six weeks to fix it.

Mr. Kimble also reported that he planned to attend the evening's Land Use Board meeting regarding transmission line setbacks.

Mr. Piper reported that DHS would have a couple of vehicle insurance claims. He also informed the commissioners that Jeff Belveal, with Colorado Parks and Wildlife, told him that his leadership didn't want to force the county to close that portion of County Road 34.2 that they discussed at the December 12 meeting. Mr. Kimble said that meant that it would be up to the county to vacate it. Mr. Burgess said it sounded like Sheriff Nestor was in favor of it, and Mr. Piper asked how they would go about it. Mr. Kimble explained that he would draw up an ordinance, adding that there would be no need to reserve anything if no county utilities were involved. He said that CPW wouldn't get a deed to the property; the road would simply disappear. If the commissioners wanted to hold a public hearing to make sure that no one had any objections, they were well within their right to do so. The Board agreed they would prefer to cover all the bases, so Mr. Kimble said he'd draw up the ordinance, and then they could set a hearing date.

The group briefly discussed the duties of the Land Use Board of Adjustments, Mr. Kimble stating that they authorize variances on the zoning ordinance. Two members of the adjustment board also have to be participants on the Land Use Board.

At 9:30 a.m., Emergency Manager Ken Stroud met with the Board to present the Emergency Management Program Grant. Mr. Burgess made a motion to approve the submission of the 2020 EMPG. Mr. Stone seconded the motion, which carried unanimously.

Mr. Stroud remained for a discussion with Sheriff Nestor and Jail Captain Michael Yowell regarding the recent drone sightings. Even though they'd attended a meeting in Fort Morgan the previous day, the sheriff said they really had no further information. They've asked the public to keep a watchful eye and report any suspicious activities or vans or trailers in out-of-the-way or unordinary places. He'd had several comments about people shooting the drones down, which they cannot do because it's against the law. Sheriff Nestor added that so far there have been no violations of the law, but he promised to inform the public if they got any further information.

Mr. Burgess brought up a recent invoice the sheriff received from the hospital for inmate medical services. Sheriff Nestor commented they needed to make sure they were doing the right thing, so he wanted time to scrub the bill to find out if the charges were all legitimate. He said they only get a statement twice a year, and this one came four days before the end of the

month, which didn't give him much time to review it. The sheriff's other concern was that he wouldn't have the money in the 2020 budget to cover the bill since he got it so late. Mr. Kimble said he'd review the statute of limitations and possibly other laws related to the issue.

The officers and Mr. Stroud left, and Town of Hugo trustee, Gillian Laycock, arrived early for the appointment at 10:30 a.m.

Mr. Schifferns called for old business, and Mr. Burgess asked Mr. Piper if he'd found chairs for them to look at for the board room. Mr. Piper provided several options, but the group agreed they didn't want leather. After some discussion, they decided not to replace the commissioners' chairs but to get two new chairs for guests and possibly have the others cleaned.

At 10:30 a.m., Town of Hugo Mayor Tom Lee, and trustees Gillian Laycock and John Thelen, met with the Board to discuss the Rural Jumpstart program from the Office of Economic Development & International Trade. Deputy Director of Business Funding and Incentives Ken Jensen attended the discussion as well as County Treasurer Jim Covington. Mr. Jensen is also the program manager for the Rural Jumpstart program. He asked if the commissioners knew anything about the program, and Mr. Burgess responded that Mrs. Laycock had shared some information about it a couple of months before. Mrs. Laycock commented that they were looking for ways to improve the town's economy and felt the Jumpstart program might be a possibility.

Mr. Jensen explained that there were four main benefits of the tax exemption program for a business that had no other competition in the state. In other words, a business had to be a brand new industry in Colorado to qualify. The eligible company would not only see exemptions from state income and sales taxes but from business personal property taxes (both county and city) as well. Additionally, all employees of the company would also benefit from an exemption from state income tax. However, Mr. Jensen said the program didn't affect real estate or county or city sales taxes.

When asked how it worked, Mr. Jensen responded that they define competition very narrowly. They examine applications thoroughly to make sure the business isn't currently operating in the state or isn't competing with another company in Colorado.

Mrs. Laycock said they've had discussions with Economic Development Executive Director Troy McCue about attracting a wind turbine blade recycler to the area. There are currently facilities in Texas and Iowa, but there are none in Colorado. Mrs. Laycock added that they could aggressively pursue the company if the commissioners agreed to adopt a resolution joining the jumpstart program.

Mr. Jensen described the process, saying that the commissioners would need to adopt a resolution stating that the county would refund or rebate all business personal property tax for four years. At the end of that period, the business could apply for an extension of another four

years; however, they couldn't go beyond eight. The OEDIT would have to approve the application for extension. For a business to locate within city limits, Mr. Jensen said the municipality would have to pass a resolution as well. The county could either start by exempting the taxes or collect and refund them afterward.

County Treasurer Jim Covington spoke up to say that if they were exempt in the beginning, the schools and other special districts wouldn't get their portion of the tax monies owed to them. Mr. Jensen said it would definitely be better to refund the county portion afterward then. Mr. Kimble asked him for a state statute that would site the information, and Mr. Jensen said it was under 39-30.5-101 C.R.S. He added that the program would expire on December 31, 2020, but they're working with the state to extend it for another five years.

Mr. Piper asked if the county had to remain committed to the program or if the commissioners could decide to withdraw from it at any time. Mr. Jensen said that anything done through a resolution could be undone that way as well. If a company were already a participant of the program, they would remain so until their four years were up. Since they would have to reapply into an already established Rural Jumpstart zone, however, they wouldn't be able to if the county were no longer a part of the program. Mr. Jensen added that the loss of business personal property tax was the only downside to the county joining.

Mr. Covington asked if the city would be responsible for refunding the city tax since the county would be accountable for returning its portion, and Mr. Jensen affirmed that was correct. He added that the county's resolution would encompass all unincorporated areas in the county, but the town of Hugo would still have to have one as well. Therefore, the city couldn't pass a resolution without the county doing so first.

Economic Development Executive Director Troy McCue arrived at 10:50 a.m. for his appointment with the Board.

Mr. Covington asked how much water the recycling facility would require, and Mr. McCue said they'd told him they didn't need very much at all. He added that it wouldn't be a huge employment creator, but it would most likely draw business from a wide arena of wind farms.

The group left, and Mr. McCue gave his report at 11:00 a.m. He commented that if there is no commitment for the Foreign Trade Zone by March 15, the county will likely lose the FTZ designation. Mr. McCue spoke about the upcoming Rural Philanthropy Days and the work going into its preparations, and also informed the Board that he'd offered the AmeriCorps Vista Volunteer position to Konner Petz from Michigan. They are pursuing electrical upgrades for the Lincoln Theatre, and are still working to improve broadband throughout the area.

After Mr. McCue left, Mr. Schifferns called for new business. Mr. Piper said he'd scheduled the new CRA representative to visit the county employees on January 15 and 16 if the commissioners wanted to meet with him.

He also provided an employment agreement with Roxana Devers as the Hugo Union Pacific Railroad Roundhouse Coordinator for 2020. Keeping in line with the Board's two-step cost of living raise, she asked for a \$.50 increase, which would bring her to \$18.00 per hour.

Mr. Burgess made a motion to approve the Employment Agreement with Roxana Devers for 2020. Mr. Stone seconded the motion, which carried unanimously.

Mr. Kimble left the meeting at 11:55 a.m. as Chris Monks stopped in to discuss diesel fuel prices. The Board agreed to have him lock in nine loads at \$2.25 per gallon, if possible. During the inspection and subsequent meeting with Shortgrass and Xcel Energy, Mr. Monks said they'd agreed to start work on County Road 2W the week of January 20, weather permitting.

At noon, Dan Hendricks and Mike Nadolsky met with the Board to discuss carpet and flooring for the courthouse. Since Chris Monks was still there, Mr. Hendricks asked if county personnel would be able to help move furniture in the courts' side of the building when they were laying carpet. Mr. Burgess noted that the road crew members might have to do it on the weekend, but they would pay them overtime. The group toured the areas as they discussed what carpet the court clerk chose and when and in which areas they could begin working. Mr. Burgess said that instead of requiring a bond, they could have Mr. Hendricks write a check to the county and hold it as they did with Daniels Electric. Mr. Hendricks said that Bart O'Dwyer might allow him to work under his bond.

The commissioners approved the remaining expenses for 2019.
