The Board of Lincoln County Commissioners met at 9:00 a.m. on July 7, 2023. Chairman Doug Stone, Commissioner Wayne Ewing, County Administrator Jacob Piper, Clerk of the Board Corinne M. Lengel, and Limon Leader reporter Stephanie Zwick attended. Vice-chairman Steve Burgess and County Attorney Stan Kimble were absent and excused.

Chairman Stone called the meeting to order and asked Mr. Ewing to lead the Pledge of Allegiance.

Mr. Burgess had sent a correction to the minutes from the June 29, 2023, commissioner meeting, so Mr. Ewing moved to approve the minutes as corrected. Mr. Stone seconded the motion, which carried.

The Board reviewed the employee timesheets for the administrator, land use administrator, landfill manager, weed control coordinator, emergency manager, and public health director. The commissioners also reviewed the monthly management report from the First National Bank of Omaha.

At 9:30 a.m., the Board reviewed an application for a Special Events Permit, Fermented Malt Beverage, for the Colorado Prairie Arts and Music Council's August 11, 2023, event at the Lincoln County Fairgrounds. Mr. Ewing moved to approve the application, and Mr. Stone seconded the motion, which carried.

Mr. Ewing moved to approve the annual reporting waiver requested by the Hugo Fire Protection District. He asked if the other fire districts in the county would need the same, but Mr. Piper said he hadn't heard from anyone else.

The commissioners reviewed the 2023 State Assessed Notice of Valuation for Lincoln County, and then Mr. Stone called for commissioner reports.

Mr. Ewing reported that Emergency Manager Ken Stroud gave him information regarding the Homeland Security grant on July 3. He also talked to District 1 foreman Chris Monks. Mr. Ewing said Chris Monks showed him bids for a new road grader on July 6. He also learned that road damage in his district wouldn't qualify for the DHS grant funds. Mr. Stone said they had well over \$100,000 of damage in District 3. Mr. Ewing attended the Limon town board meeting on the evening of July 6, where they discussed the difficulty the Limon Police Department had obtaining qualified applicants for open positions. They recently lost another officer to the sheriff's office and now had two positions to fill. The town board also discussed areas where the town sewer system backed up.

Mr. Stone reported meeting with Judd Kravig on July 5 to discuss roads and equipment. They still hadn't gotten the rental tractor from Case International. Mr. Stone and Mr. Ewing discussed it via text message later that evening. Mr. Stone said rumor had it that lightning struck two of the tractors, so he wanted to contact Mike Vaughn and find out. Mr. Stone checked roads and washouts on July 6. He and Judd Kravig, Cory Stark, Ken Stroud, and two state inspectors looked

at the washed-out culverts and two bridges in District 3. The tubes had washed out twice in the past eight years, and the inspectors told Mr. Stone the county needed two new bridges. Mr. Stone said they'd wait for an estimate and how much funding the county would get before deciding but closing that half mile of the road might be more cost-effective. He estimated only ten or twelve vehicles used it each day. Mr. Stone said they hired a part-time person to mow for the next two months but were still down one employee.

Mr. Ewing had talked to Chris Monks about mowing, but Mr. Monks wasn't sure they had anyone to do it. District 1 had another employee guit, so they were one man short too.

Mr. Piper reported receiving another protest report from the assessor and shared it with the Board. He asked if the commissioners wanted to adopt the resolution opposing Proposition HH and said Elbert County hadn't done so yet, nor had Kit Carson, Cheyenne, or Yuma counties. Mr. Stone felt it should be on a meeting agenda to reach more people in case anyone had comments, and Mr. Ewing asked if they could publish it in the paper. Mr. Stone said a statement might be appropriate, but publishing a complete resolution wasn't necessary. Mrs. Zwick said she would add it to her report from this meeting.

Mr. Stone called for old or new business. Then he asked Mr. Ewing if he'd received Sheriff Nestor's text message regarding county residents' property and vehicle damage from the previous night's weather.

The Board called Mike Vaughn with Case International to ask about the rental tractors. Mr. Vaughn said they had a couple get hit by lightning but that he'd contact the store and find out what information he could.

Mr. Stone asked if Mr. Piper had heard anything more on the courthouse roof, but he'd gotten no further information. He also hadn't heard anything regarding the lobby flooring, and Mr. Stone said they should try to get a couple of bids.

When Mr. Ewing asked if John Mohan had hired janitors for the courthouse and annex, Mr. Piper said he'd put an ad in the paper for the courthouse janitor. They had received one application and had another party interested in the annex job.

Mr. Stone said he would need to leave the July 18 meeting at 11:45 a.m. but could return if necessary. Mr. Piper didn't have much on the agenda and said he would try not to schedule anything after 11:00 a.m.

Mrs. Lengel said several community members had asked her why no flags were flying in front of the courthouse and that they hadn't been for quite a while. Mr. Piper thought the sheriff's office took care of them and said he would find out.

Mrs. Lengel also said she'd attended a session at her summer clerks' conference the previous week regarding counties moving to .gov websites. The state and Colorado County Clerks

Association wanted all counties to have them before the June 2024 primary election. Having .gov verified the county was a trusted government site, and while not necessarily *more* secure, it meant it enforced security and was, therefore, harder to spoof. Mrs. Lengel had spoken with James Martin about possibly moving from .us emails to .gov emails since the county already had the .gov domain on its website. She offered to talk to him again and said it might be a good topic for a department head meeting.

Mrs. Lengel asked if the commissioners would be interested in selling items at the Hugo townwide yard sale again over Labor Day weekend. She had several things to get rid of and thought other departments might as well. Mr. Piper said the county had made decent money on it last year, and they agreed to discuss it with other departments.

The commissioners approved the expenses for June 2023.
