The Board of Lincoln County Commissioners met at 9:00 a.m. on March 7, 2023, in the County Administrator's office. Chairman Doug Stone, Commissioners Steve Burgess and Wayne Ewing, County Administrator Jacob Piper, Clerk of the Board Corinne M. Lengel, Deputy Clerk of the Board Ryan Davis, and Limon Leader reporter Stephanie Zwick attended. County Attorney Stan Kimble was absent and excused.

Chairman Stone called the meeting to order and led the Pledge of Allegiance.

Mr. Burgess moved to approve the minutes from the meeting on February 27, 2023, as submitted. Mr. Ewing seconded the motion, which carried unanimously.

The Board reviewed the employee timesheets from the administrator, land use administrator, landfill manager, weed control coordinator, and emergency manager. Mr. Burgess noted that the Public Health Director's timesheet wasn't with the others, and Mr. Piper said he'd text Mrs. Meier and ask her to bring it down.

The commissioners reviewed the County Veterans Service Officer's Monthly Report and Certification of Pay and the monthly management report from the First National Bank of Omaha.

Mr. Piper said Mr. Kimble had looked over the participation forms regarding recent opioid settlements and thought they were fine. He explained that five more companies were involved and would make payments; however, Lincoln County would not receive any because its portion would go to the region. Mr. Burgess moved to approve the participation forms, and Mr. Ewing seconded the motion, which carried unanimously.

Mr. Piper provided the results of the Lincoln County health insurance survey and said that of the eighty-eight county employee participants, one hundred percent liked the current benefits. The county averages 98-110 employees who receive health insurance benefits monthly, so it was an excellent response. Mr. Burgess asked Mr. Piper to send the survey results to CTSI, saying it was always nice when the commissioners received positive feedback, and CTSI might appreciate it too.

Mr. Burgess reported going to the Genoa shop on February 27. He also gave Ron Boyd permission to push the snow back on County Road 3V. The road crew hauled gravel to various spots and continued doing so on February 28. Mr. Burgess checked with Bruce Walters about signs for the bridge, but he didn't know if they'd come in yet. He also received a call asking about the fair parade incident, but neither Mr. Piper nor Mr. Kimble had heard anything. Mr. Burgess toured roads north and east of Genoa on March 1—they have a lot of repairs to do. He received a complaint about the old weather station; the complainant said the owner keeps bringing in more stuff. Mr. Burgess checked it out and said there appeared to be more trucks, metal supports, and other items than before. He informed Mr. Stone and Mr. Ewing and asked them to look at it. He then contacted Ty Stogsdill, who said he'd check to see what the county allowed. Mr. Burgess attended the COG meeting in Limon and reported that Lisa Hector from

Karval is the new Outback bus driver. On March 2, Mr. Burgess called Mr. Stone to see if they could leave the bus at the county shop in Karval, which wasn't a problem. Mr. Burgess attended the Baby Bear Hugs meeting via Zoom. Their annual gala is on April 22 in Yuma. They'll do a fundraiser golf tournament in Limon on July 15 and will auction off a donated pair of tickets to the Chauncey Williams concert at the Lincoln County Fair on August 11. Mr. Burgess said they'd likely add a hotel room to make it a package deal. Mr. Burgess reported that the District 2 road crew hauled gravel on County Road 3V and that a farmer called to thank the county for putting gravel on the road. Mr. Burgess checked roads on March 3 and went to Genoa, where he and Mr. Walters toured some roads. They also looked at the property that needed cleaning up; it was still snowy and muddy. The road crew plowed snow north of Genoa on March 4 and hauled more gravel on March 6. Mr. Burgess talked to Mr. Stogsdill on March 6 about some property and subdivision regulations and exemptions.

Mr. Ewing reported speaking with Mr. Burgess on March 1 about the Johnson property on State Highway 71 at the old weather station. Mr. Ewing felt there had been some activity, but Mr. Johnson hadn't done anything with the doublewide mobile home. Land Use Administrator Ty Stogsdill told him Mr. Johnson seemed to be in compliance at this time and that he had until June to do something with the trailer house. On March 2, Mr. Ewing went to the Hugo shop and talked to Chris Monks about the new GMC pickup. He also attended the New Miner Safety Class at the courthouse. At the Limon town board meeting that night, members discussed a possible free landfill day on Earth Day, but Mr. Ewing told them it was usually in May, around Mother's Day. The new swimming pool will open over Memorial Day weekend, and there will be an announcement later on for the grand opening. Mr. Ewing said town board members also discussed the routes regarding the new ordinance allowing golf carts and UTVs on city streets. On March 3, Mr. Ewing spoke with Chris Monks about roads that needed attention. They bladed and hauled fill to several areas, including the landfill road and County Road G. They also discussed a Workers' Comp claim. Mr. Ewing attended the Eastern TPR meeting in Akron with Mr. Stone on March 6. He commented they had plenty of projects but were short on funds.

Mr. Stone noted that the regional CDOT meeting would be on May 23 in Limon. He reported speaking with Judd Kravig on February 28. Mr. Kravig had gone to Denver to look at the used truck and plow but reported back that the plow was only 10' wide, which he felt would be too narrow. Mr. Burgess commented that there was an extra plow at the county shop that Mr. Stone and Mr. Kravig could look at to see if it would work for them. On March 1, Mr. Stone talked to Mr. Monks and Mr. Kravig about pickups and the CAT bill they received for the grader repairs. Mr. Stone felt they charged too much, especially for what the county pays to have the unit under warranty. The rep was coming out to visit with them about it. District 3 planned to haul material from the Brewer Pit but would leave the roto mill. Mr. Stogsdill told Mr. Stone he'd thought the place sold, and Mr. Stone said he hoped the new owners would allow the county to use the gravel pit. Mr. Stone reported that he'd talked to Mr. Burgess about the Outback bus and Mr. Ewing about pickups. He checked various roads on the afternoon of March 3 and attended the Eastern TPR meeting with Mr. Ewing on March 6. They discussed numerous roads and projects, including potholes and snow removal.

Mr. Piper said Mr. Kimble had nothing to report except reviewing the opioid settlement participation forms.

Mr. Piper reported that John Palmer had called to tell him a group wanted to hold motorcycle races at the fairgrounds in September. As for insurance coverage, CTSI recommended \$1 million for personal and liability. Mr. Burgess felt the races would cause quite a bit of damage to the track.

Mr. Stone said he'd talked to Mr. Palmer about the old arena lights, and KC Electric wouldn't drop them because they were too busy. Mr. Palmer felt it would only take about three hours to unbolt and drop them and suggested asking Mountain View Electric. Mr. Palmer was afraid that if the county put the job out for bid, whoever got the bid wouldn't have the proper equipment to do the job. Mr. Ewing said they should contact Mountain View, who might consider giving back to the community after their recent issues with the broadband project.

Mr. Piper asked the commissioners if they wanted Mr. Palmer to get more information on the motorcycle races, but they agreed it would cause too much damage to the track. Mr. Stone added that there had to be other places they could have them. Mr. Piper said he'd tell Mr. Palmer the Board's decision.

Mr. Piper informed the Board that a considerable amount would come from the pension plan fund because of a recent retirement. Although some plans automatically allow disabled, not of retirement age, employees to move to retirement age, the county's plan doesn't do that. Mr. Piper explained that the commissioners could choose to allow it if they wanted; otherwise, the employee could lose a lot of their vested portion. He added that the plan reps were looking into it and talking to the actuarial company. The company providing the calculations said the employee could petition the commissioners to treat them as retirement age but adding that language to the retirement plan documents could significantly increase the county's liability.

Mr. Stone wanted to know the cost difference if the Board agreed to allow the employee to retire as a 65-year-old. Mr. Piper calculated half a percent by the number of months the employee was away from turning sixty-five but said he didn't know if that only applied to annuities. The particular employee planned to take the lump sum.

Mr. Ewing felt that allowing it to happen once would set a precedent, and Mr. Burgess agreed. Mr. Piper said the company doing the calculations suggested ensuring the employee was fully vested and treating it as an early retirement. He added that if the commissioners wished to change the plan, they would likely need to involve the plan attorney, and since the plan wasn't yet fully funded, it might not be cost-effective.

Mr. Burgess said they shouldn't change the plan but that he would still like to know how much the employee would lose from the vested portion.

The Board discussed a free landfill day, and Mr. Ewing moved to have it on May 6, with an alternate date of May 13. Mr. Burgess seconded the motion, which carried unanimously. Mr. Piper said he would wait a few weeks to advertise it.

Mr. Burgess brought up the only old or new business, stating he'd sent the group a couple of Cheyenne County resolutions that he would like them to review and think over.

Since it was only 10:30 a.m., Mr. Stone asked if they could conduct their on-site jail examination before 11:30. The sheriff asked them to give him ten minutes, and then at 10:45 a.m., the Board conducted an on-site inspection of the Lincoln County Jail, according to 17-26-126, C.R.S.

When they'd finished, the commissioners looked at the progress of the election security room construction and then returned to the Administrator's office to approve the February expenditures.
