


Ballot Type: 3CC

Official Ballot for 2023 Coordinated Election **Lincoln County, Colorado** Tuesday, November 7, 2023





To vote for a named candidate, or for or against a ballot measure, completely fill in the oval to the right of your choice. Use blue or black ink.



To vote for an eligible write-in candidate, completely fill in the oval to the right of the write-in line, and print the name of the candidate on the line. If a race does not contain a write-in line, you cannot vote for a write-in candidate.



To make a correction in a race with more than one candidate, draw a bold line through the oval and candidate name marked by mistake, then fill in the oval next to the correct name. If you voted for the only candidate in a race and want to withdraw that vote, you must request a replacement ballot.

WARNING: Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges, or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. CROWLEY COUNTY SCHOOL DISTRICT RE 1-J BALLOT ISSUE <u>5A</u>: BONDS

SHALL CROWLEY COUNTY SCHOOL DISTRICT RE 1-J DEBT BE INCREASED UP TO \$11.78 MILLION WITH A REPAYMENT COST OF UP TO \$19.9 MILLION, AND SHALL DISTRICT TAXES BE INCREASED BY UP TO \$995,000 ANNUALLY, WITH THE INCREASE IN DEBT TO OCCUR ONLY IF THE SCHOOL DISTRICT RECEIVES A "BEST" GRANT WHICH EXCEEDS \$50 MILLION IN AWARDED "BEST" GRANT FUNDS (WHICH ARE NOT REQUIRED TO BE REPAID), AND SEEKS ADDITIONAL GRANT OPPORTUNITIES TO FINANCE THE COSTS OF:

- THE CONSTRUCTION OF A NEW CONSOLIDATED K-12 BUILDING, INCLUDING VO-AG AND ATHLETIC FACILITIES, WITH OUTDOOR PLAY AREAS AND SAFE SUFFICIENT PARKING, STUDENT PICKUP AND DROP OFFS ON A SINGLE CAMPUS CURRENTLY OWNED BY THE DISTRICT TO ADDRESS HEALTH, SAFETY, SECURITY, AND EDUCATIONAL DEFICIENCIES IN THE DISTRICT'S CURRENT SCHOOL FACILITIES:

BY THE ISSUANCE AND PAYMENT OF GENERAL OBLIGATION BONDS WHICH SHALL BEAR INTEREST, MATURE, PERMIT REDEMPTION, AND BE ISSUED AT SUCH TIME AND PRICES (AT, ABOVE OR BELOW PAR), AND CONTAINING TERMS CONSISTENT WITH THIS BALLOT MEASURE AS THE BOARD OF EDUCATION DETERMINES; AND SHALL AD VALOREM PROPERTY TAXES BE LEVIED WITHOUT LIMIT AS TO THE MILL RATE TO GENERATE AMOUNTS, NOT TO EXCEED THE ABOVE AMOUNTS, SUFFICIENT IN EACH YEAR TO TIMELY PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS?
